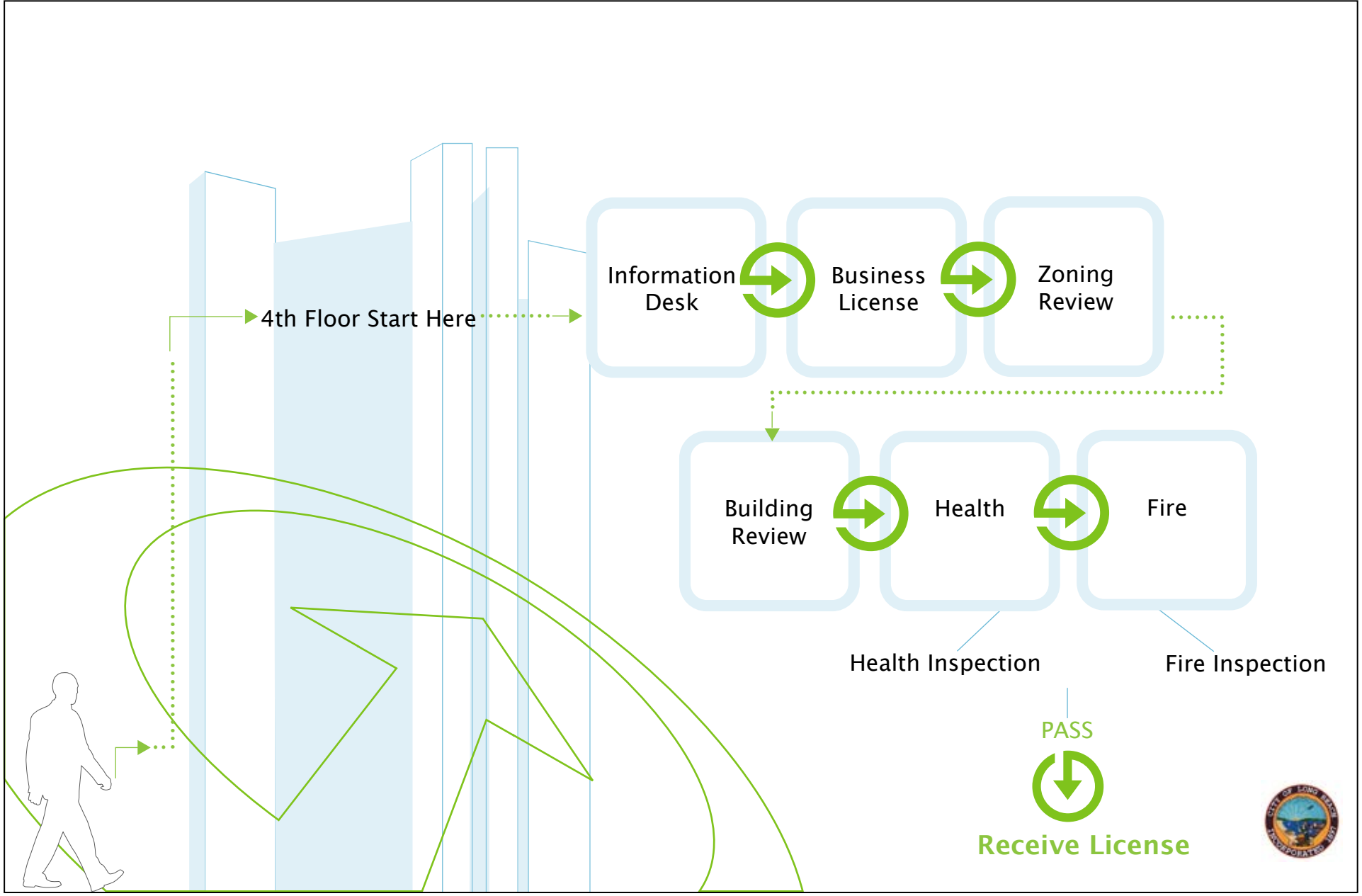

## Food Preparation Business License Guide

Welcome to the Business License department. You are one of thousands of entrepreneurs who recognize Long Beach as the prime business location in Southern California.

This guide applies to food preparation businesses such as **restaurants, fast food restaurants, bakeries, food processing, wholesale preparation, and the like**. If, after reading the guide, you have additional questions, stop by the Development Services Center, 4<sup>th</sup> Floor, City Hall, to meet with one of our Business License experts.

### Alcohol Sales

- Receive authorization from City Council prior to receiving your business license
- Consult with the [California Department of Alcohol Beverage Control](#) (ABC)

### Application Submittal

- Fill out completely a Business License Application available
  - ➔ In person – Development Services Center, 4<sup>th</sup> Floor, City Hall, 333 W. Ocean Blvd. or
  - ➔ Online – download and print – [Business License Application](#)
- Fill out separate Business License Applications if your establishment will include entertainment, pool tables and / or video or amusement machines
- **Submit your completed application(s) in person at the Development Services Center**

### Fees and Taxes

These fees are paid when you submit your Business License Application:

Basic Business License tax	\$320.70
Plus per-employee tax	\$8.33

### Approvals and Inspections

The Development Services Center staff will determine if you need to complete a Fire and / or Health inspection.

These fees are paid when you submit your Business License Application:

Zoning Investigative fee	\$14.00
Building Bureau Application Review fee	\$39.83
Health / Food Permit	\$120.00
Tobacco Retail Permit (if applicable)	\$469.00
Fire Inspection fee	\$159.30*

Businesses selling alcohol will be referred to the Police Department for review

Other fees may apply.

\* Health and Fire departments will inform you of their fees, which are determined by your type of business
