## COVID-19 Updates

### Coronavirus (COVID-19) Update

#### By the Numbers (Long Beach only | as of 5/21/20):

- 1,495 total positive results
  - Daily reporting of case counts continues to fluctuate due to heavy demand for testing (due to the wider scope of testing criteria) and backlog at various laboratories, causing delays in reporting.
- 68 fatalities
- 62 people hospitalized
- Approximately 991 recovered (Please note that, for low-risk patients recovering at home, recovery data is self-reported)
- Data snapshot is as of 12:01 a.m. today

#### Details Regarding Fatalities:

- 52 are associated with long-term care facilities
- One individual was in their 40s, four individuals were in their 50s, 16 were in their 60s, 16 were in their 70s, 18 were in their 80s, and 13 were over 90 years old



- 37 individuals were men and 31 were women
- All individuals had underlying health conditions
- At this time, to avoid risk to patient privacy, no further details will be provided

### **Long-Term Care Facility Case Information:**

- 415 positive cases have been confirmed at a total of 25 long-term care facilities in the city since the start of the pandemic (25 is a cumulative number; the Health Department is currently monitoring long-term care facilities with active cases). These cases include both facility residents and staff members (who may not be residents). Long Beach has a total of 93 long-term care facilities.

In line with the California Department of Public Health's standard for [listing skilled nursing facilities](#) with positive cases, the City is listing facilities currently experiencing outbreaks (more than two cases of COVID-19) including counts for health care workers and residents (see attachment).

### **Testing for Long Beach Residents:**

- Diagnostic testing in Long Beach is available for anyone with symptoms of COVID-19. Certain locations are also testing essential workers who may have been exposed but are not showing symptoms. Same or next day appointments can be made online and are prioritized for those 65 years or older; individuals with underlying chronic health conditions; and first responders, critical government workers, grocery workers, and health care professionals. ## Street Sweeping Parking Enforcement Update

On Monday, the moratorium on street sweeper parking citations was lifted. At Tuesday's council meeting, we received a report on how the first two days of enforcement went. There were two main outcomes from the meeting. First, unpaid citations will not be forwarded to the DMV for collection until approval from city council. Second, the City will forgive citation fees where a COVID-19 hardship can be demonstrated. We hope to have more details on that process in next week's newsletter. 

## Past Events

### Study Session on Our City's Budget

During last Tuesday's council meeting, a study session was held titled, "Budget Update and Restart of the Budget Process Projections, Goals, and Proposed Actions". Discussion topics included: financial strength of the City, impact of COVID-19 pandemic on economy and services, projection update and budget process, goals and strategies for budget balancing. One of the staff recommendations listed on slide 24 states: "Defer decisions on the fire and police academies until later in the FY 21 budget process to better understand funding and budget ramifications". As I mentioned in a previous newsletter, I believe it is critical that we conduct a fire academy in August 2020, and I will continue working on that goal. 

## Redistricting Commission Application Update

The population of Long Beach is divided into nine council districts, and each district is required to have the same number of residents. With shifting populations, the district boundaries have to be adjusted in a process called redistricting. In 2021, Long Beach will redraw its district boundaries and residents are given the opportunity to be part of the change. On November 6, 2018, voters approved Measure DDD that amended the City Charter to create a Commission of Long Beach residents to determine the boundaries of Council Districts every ten years after the national census. The Commission will be comprised of 13 members and 2 alternates, who reflect the diversity of the city and will act as an independent body. ## Memorial Day Closures

Monday, May 25th | Citywide

In addition to the standard holiday closures of City facilities and services, resources enacted for COVID-19 response will also close in observance of Memorial Day on Monday, May 25th. These include all Long Beach COVID-19 testing sites and the Rapid Assessment Clinic (RAC). The INFO Hotline (570-4636) will close operations on Saturday, May 23 and Sunday, May 24 but will be back in operation on Monday, May 25. ## And Finally

### Jacaranda Trees of Council District 4

Our council district is typically associated with man-made iconic structures such as the Traffic Circle, Community Hospital and Joe Jost's tavern. However, we are also home to the City's greatest concentration of one particular natural beauty. The purple-blooming jacaranda trees are in greater abundance in the Los Altos neighborhood than

anywhere else. The LBPost produced the purple "heat map" below from data compiled by the LA Times. It clearly shows the most densely populated area of the City's 6,799 jacarandas is bordered by Clark Ave., Stearns St, Fanwood Ave. and Atherton St. There are notable CD4 exceptions outside the area including Stearns Park, Plaza Zaferia and individual tree-lined streets. Earlier this week, We Love Long Beach recorded a drive along Fidler Ave that you can view by clicking the arrow below.




