

The CHAMPS program, provides 10 units of scattered site, permanent supportive housing, targeting chronically homeless veterans and families in Long Beach. Veterans served through this project suffer from physical or mental disabilities and/or substance dependence. Supportive services are supplied on the campus of the Villages at Cabrillo residential planned community. Services include job/vocational training programs, life skills classes, legal advocacy, a dining hall, community college courses, a career center, VA social workers, a substance abuse treatment program, and healthy food options. Participants will be able to travel to these services as needed by bus which stops directly on the campus.

The Multi-Service Center is the central hub for intake and assessment of individuals experiencing homelessness. The U.S. VETS Outreach Team collaborates with other service providers to maximize outreach through the City of Long Beach and is the initial point of contact for chronically homeless veterans. The team works conjunctively with the Street Outreach Network to reach those experiencing homelessness. Collaboration with providers, community members, and connection with homeless portals in the region, are tools that present the services and housing options available to the veteran community. Those experiencing homelessness are assessed and placed into housing using a housing first approach. Housing First prioritizes rapid placement and stabilization in permanent housing without service participation requirements or preconditions. The harm reduction model reduces the length of time a person experiences homelessness, removes barriers to housing, and affords participant choice in selection of housing options available to them, giving them the ability to access housing quickly with subsequent resources to maintain housing stability.

The project will achieve the following outcomes:

- (i). 6 months or less - reduce the length of time between Client's Project Start Date and Move-in Date.
- (ii). 90% -meet the # of persons to be served annually.
- (iii) Less than 5% -Reduce the # of persons exiting back to homelessness
- (iv). 90% - increase residential project occupancy.
- (v). 15% - Persons age 18 or older increase earned income during operating year.
- (vi). 50% - Persons age 18 or older increase non-employment cash income during operating year.
- (vii). 80% -increase the # of persons exiting to permanent housing.
- (viii). 90% - increase the # of persons remaining in permanent housing.
- (ix). Less than 5% - reduce the # of persons exiting with unknown destination.
- (x). Less than 5% - reduce the # of persons exiting with no financial resources.

This is in response to your request of February 9, 2004, regarding your organization's tax-exempt status.

In December 1992 we issued a determination letter that recognized your organization as exempt from federal income tax. Our records indicate that your organization is currently exempt under section 501(c)(3) of the Internal Revenue Code.

Based on information subsequently submitted, we classified your organization as one that is not a private foundation within the meaning of section 509(a) of the Code because it is an organization described in sections 509(a)(1) and 170(b)(1)(A)(vi).

This classification was based on the assumption that your organization's operations would continue as stated in the application. If your organization's sources of support, or its character, method of operations, or purposes have changed, please let us know so we can consider the effect of the change on the exempt status and foundation status of your organization.

Your organization is required to file Form 990, Return of Organization Exempt from Income Tax, only if its gross receipts each year are normally more than \$25,000. If a return is required, it must be filed by the 15th day of the fifth month after the end of the organization's annual accounting period. The law imposes a penalty of \$20 a day, up to a maximum of \$10,000, when a return is filed late, unless there is reasonable cause for the delay.

All exempt organizations (unless specifically excluded) are liable for taxes under the Federal Insurance Contributions Act (social security taxes) on remuneration of \$100 or more paid to each employee during a calendar year. Your organization is not liable for the tax imposed under the Federal Unemployment Tax Act (FUTA).

Organizations that are not private foundations are not subject to the excise taxes under Chapter 42 of the Code. However, these organizations are not automatically exempt from other federal excise taxes.

Donors may deduct contributions to your organization as provided in section 170 of the Code. Bequests, legacies, devises, transfers, or gifts to your organization or for its use are deductible for federal estate and gift tax purposes if they meet the applicable provisions of sections 2055, 2106, and 2522 of the Code.


