Proposed Project: An appeal (APL 19-006) of the Planning Commission's November 7, 2019 decision to accept the mitigated negative declaration for the Long Beach Cruise Terminal Project consisting of onshore and maritime improvements and approval of a site plan review for a project consisting of a 657 stall parking structure expansion, filling of an abandoned tunnel, and the reconfiguration of the traffic lanes near the parking garage in the Queensway Bay Planned Development (PD-21) Zoning District. (District 2)

Environmental Review: Pursuant to the California Environmental Quality Act (CEQA) and the State CEQA Guidelines, an Initial Study/Mitigated Negative Declaration (IS/MND-08-19, State Clearinghouse No. 2019069085) for the Long Beach Cruise Terminal Project has been prepared for the project and finds that by implementing identified mitigation measures, the project will not result in significant effects to the environment. The IS/MND was initially circulated for a 30-day public review period between June 20, 2019 to July 22, 2019 and then recirculated for another 30-day review period between August 28, 2019 through September 26, 2019.
