Proposed Project: City-led project to revitalize Belmont Pier Plaza by removing one unhealthy Coral tree and replacing with two trees, and providing the following: LED lighting, new planter palette, refurbished irrigation, interpretive land and wayfinding signage, walkway mural, and refreshed paint in the Park (P) District and Belmont Pier (PD-2) District (District 3)

This northern portion (approximately 19,000 sq. ft.) of this project **IS** located in the Coastal Zone and **IS** appealable to the Coastal Commission. The southern portion (approximately 5,400 sq. ft.) of this project **IS** in the California Coastal Commission Original Permit Jurisdiction and will be subject to Coastal Commission review following City action.

Environmental Review: This project qualifies for a categorical exemption per Section 15301 (Existing Facilities) of the California Environmental Quality Act Guidelines. (CE20-048)

If you seek judicial review of any decision of the City pursuant to California Code of Civil Procedure Section 1094.5, the petition for writ of mandate pursuant to that section must be filed no later than the 90th day following the date on which the City's decision became final pursuant to California Code of Civil Procedure Section 1094.6. There may be other time limits which also affect your ability to seek judicial review.
