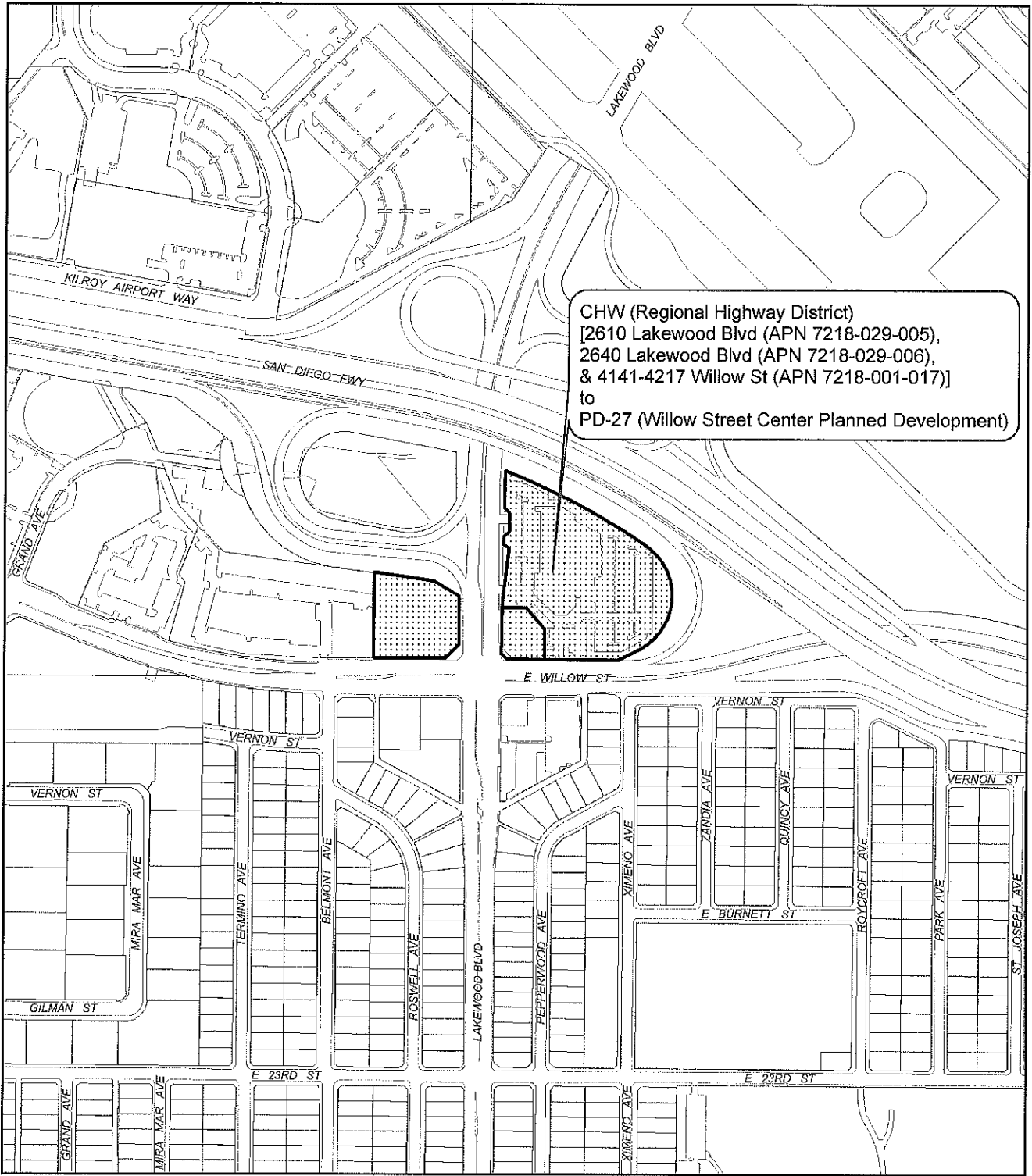
AN ORDINANCE OF THE CITY COUNCIL OF THE
CITY OF LONG BEACH AMENDING THE USE DISTRICT
MAP OF THE CITY OF LONG BEACH AS SAID MAP HAS
BEEN ESTABLISHED AND AMENDED BY AMENDING
PORTIONS OF PART 17 OF SAID MAP FROM REGIONAL
HIGHWAY DISTRICT (CHW) TO WILLOW STREET
CENTER PLANNED DEVELOPMENT (PD-27)

The City Council of the City of Long Beach ordains as follows:

Section 1. Environmental documentation having been prepared, certified, received and considered as required by law, and the City Council hereby finding that the proposed change will not adversely affect the character, livability or appropriate development of the surrounding area and that the proposed change is consistent with the goals, objectives and provisions of the General Plan, the official Use District Map of the City of Long Beach, as established and amended, is further amended by amending portions of Part 17 of said Map to zone the subject parcels at 2610 Lakewood Boulevard and 2640 Lakewood Boulevard, and 4141-4217 Willow Street from Regional Highway District (CHW) to Willow Street Center Planned Development District (PD-27).

Section 2. Those portions of Part 17 of said map that are amended by this ordinance are depicted on Exhibit "A" which is attached hereto and by this reference made a part of this ordinance and the official Use District Map.

Section 3. All ordinances and parts of ordinances in conflict herewith are hereby repealed.

Rezoning Map


