RE: Support for SB 1130 (Gonzalez): Telecommunications: California Advanced Services Fund

Dear Senator Gonzalez:

On behalf of the City of Long Beach (City), I write in support of Senate Bill 1130 (Gonzalez). This legislation amends the California Advanced Services Fund to award telecommunication infrastructure projects that provide modern and high-capacity infrastructure to unconnected and underconnected areas. The City is committed to addressing the digital divide through its Digital Inclusion Initiative (Initiative), which focuses on ensuring that everyone in Long Beach has equitable access to and use of digital literacy training, the Internet, technology devices, and other digital resources. The Initiative would benefit from the funding mechanism SB 1130 proposes, to secure digital infrastructure investments in Long Beach's unconnected and underconnected communities.

Long Beach continues to be named a Top 10 Digital City by the Center for Digital Government. In November 2019, Long Beach was recognized with this award for the 9th consecutive year. While new technological advancements have helped the City achieve such recognition, a glaring weakness remains—a large portion of the Long Beach community does not have access to and use of in-home Broadband Internet. This finding led to a unanimous City Council decision in 2018 to approve the Initiative's development of a Digital Inclusion Strategic Plan and Roadmap (Roadmap). The City is in the process of co-creating the Roadmap with community members and local stakeholders. The foundation of the Roadmap will include a vision, goals, objectives, performance indicators, and strategies for advancing digital inclusion through a collective impact approach and equity lens as they relate to capacity, connectivity, and technology. Once the Roadmap has been developed, City staff will work closely with the community and local stakeholders to develop implementation action plans.

As an affiliate of the National Digital Inclusion Alliance (NDIA), the City supports legislation that eliminates the digital divide. Additionally, SB 1130 aligns with the City's efforts to provide economic relief to Long Beach households following State and local emergency declarations due to the COVID-19 pandemic. Digital divide funding mechanisms are imperative to foster stability, particularly during times of uncertainty, and SB 1130 will help support commitments to digital inclusion during and after the COVID-19 state of emergency.

Given these reasons, the City of Long Beach supports SB 1130 (Gonzalez).
