Subject: **Medical Marijuana Business License Program Update**

This memorandum provides an update on the medical marijuana program in Long Beach, including the current status of business license applications for dispensaries, cultivators, manufacturers, testing laboratories, and distributors. For a citywide map showing the locations of all licensed and pending medical marijuana locations in Long Beach, please refer to Attachment A. Additional details on specific marijuana license categories are provided below. Staff will continue to provide regular updates to the Mayor and City Council as additional information becomes available.

Dispensary Applications

The Non-Priority dispensary public lottery was conducted on September 28, 2017. All medical marijuana dispensary locations eligible to proceed through the application process have now been selected. Pursuant to the Long Beach Municipal Code, 32 medical marijuana dispensary businesses will be licensed to operate in the City. For a complete list of all licensed and pending dispensary locations, please refer to Attachment B.

The first medical marijuana dispensary license was issued on September 26, 2017. The business license was granted to LB Green Room, located at 1735 East 7th Street. Staff anticipates that the second medical marijuana dispensary license will be issued to Connected Belmont Shore in early October. Connected Belmont Shore is located at 5227 East 2nd Street. None of the remaining medical marijuana dispensary applicants are expected to open soon, based upon estimated construction timelines. The majority of medical marijuana dispensaries in Long Beach will likely not open until the end of 2017, or early 2018.

The City is accepting applications for all non-dispensary medical marijuana license types, including cultivation, manufacturing, testing, and distribution. Applications are processed in the order they are received. To date, 48 non-dispensary medical marijuana business license applications have been submitted. Only 24 of these applicants have been allowed to proceed to the Department Review Phase for plan checks and inspections. All other applications are currently being reviewed for completeness.

Unlike dispensaries, there is no cap on the number of other medical marijuana business types that may operate in Long Beach. As long as each applicant is able to satisfy the requirements set forth in the Long Beach Municipal Code for medical marijuana businesses, they will be eligible to receive a medical marijuana business license. At this time, none of the non-dispensary applicants have been issued a business license to begin operating.

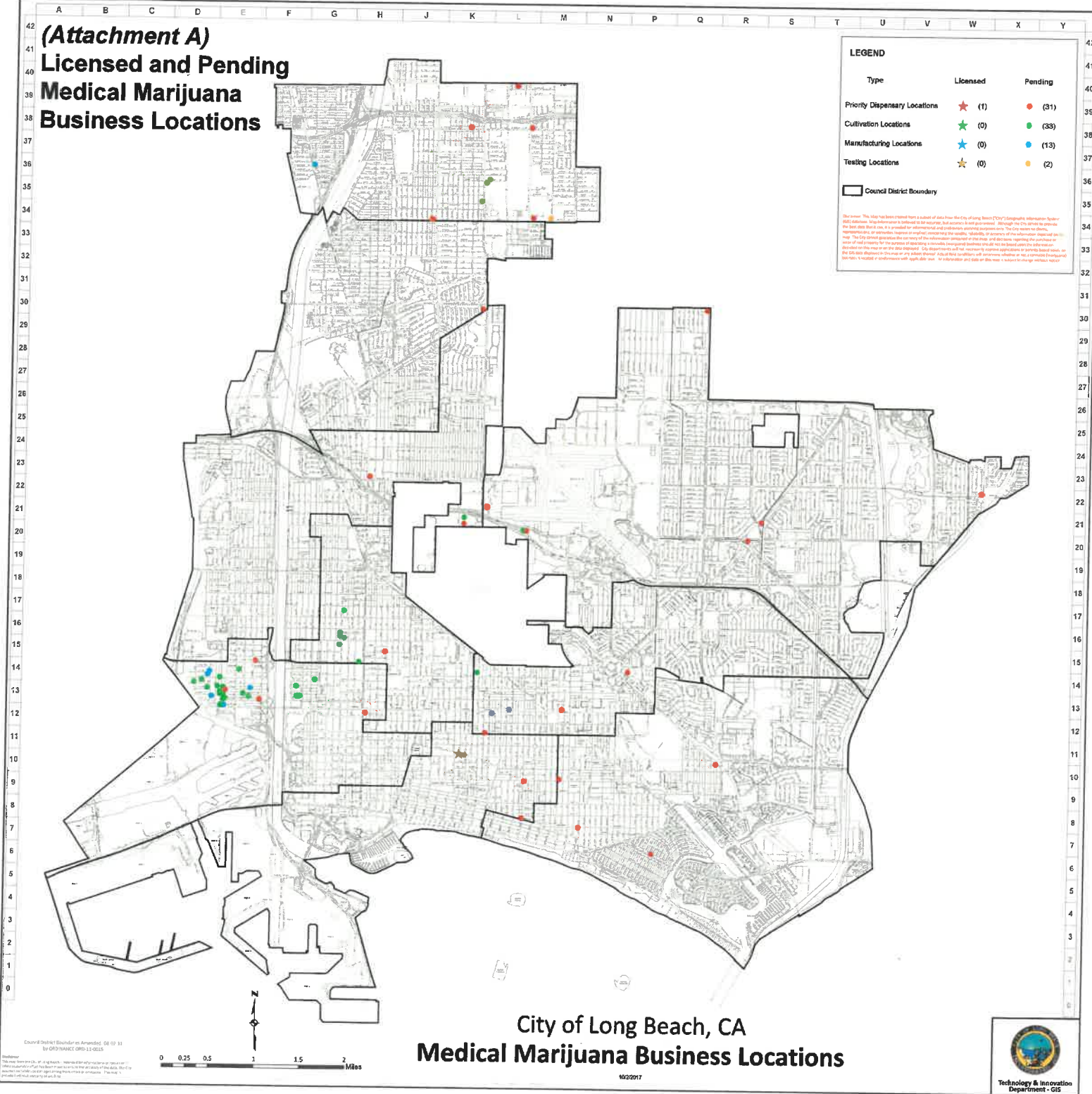
