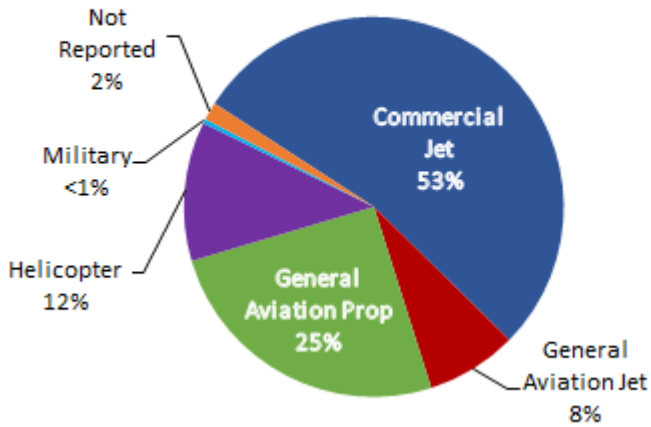

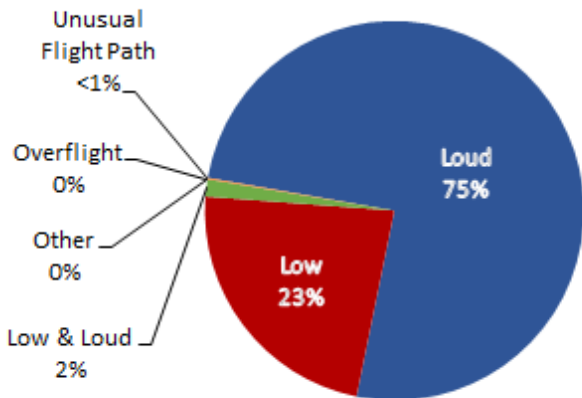
Complaints by Aircraft Types



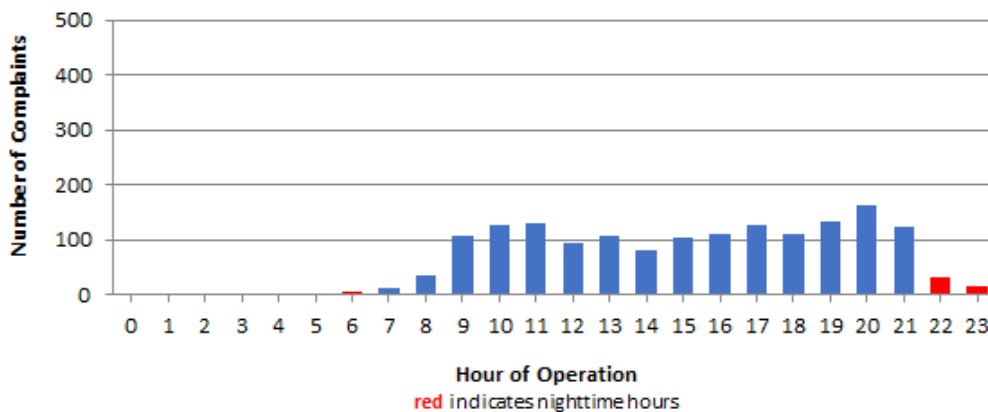
