Subject: **SCAG Regional Council District 30 – Long Beach Representative Selection**

The City of Long Beach (City) is currently seeking a representative for the Southern California Association of Governments (SCAG) Regional Council District 30 for the term of May 2, 2024, through May 7, 2026.

Long Beach holds two seats on the SCAG Regional Council for Districts 29 and 30. Councilmember Suely Saro serves on the SCAG Regional Council for District 29, which includes the cities of Long Beach and Avalon. Vice Mayor Cindy Allen serves on the District 30 seat, which encompasses only Long Beach. When a District encompasses only one city or part of only one city, that city shall appoint its District Representative from among its city council members by action taken at a meeting of said city council or by any lawful appointment action or process deemed appropriate by the city.

As a SCAG Regional Council representative, the member is eligible to:

- Serve on one of SCAG's policy committees: Community, Economic and Human Development; Energy and Environment; or Transportation;
- Be appointed by the SCAG President to other SCAG committees;
- Receive a \$120 stipend for attending SCAG meetings or SCAG-sponsored events;
- Receive public transit or mileage reimbursement (based on travel distance between the member's seat of government and SCAG's meeting/event location);
- Receive parking validation at SCAG's Los Angeles office; and,
- Receive lodging reimbursement for SCAG-related travel, requirement of 75 miles or more one-way.

All regular meetings of the Regional Council and Policy Committees are scheduled for the first Thursday of each month. Attached is the 2024 Schedule of Meetings.

How to Express Interest

To be considered for the SCAG District 30 seat, please submit your interest to Mayor Rex Richardson by end of day on Thursday, March 21, 2024. If only one representative expresses interest in serving on the SCAG board, they will be the City's representative for the District 30 seat. However, if more than one Councilmember expresses interest, the City Council will have to vote to select the City's District 30 representative among
