FOR GOOD AND VALUABLE CONSIDERATION, including permission to participate in the 65<sup>th</sup> ANNUAL DAISY AVENUE CHRISTMAS TREE LANE PARADE and related activities ("Event"), I, for myself, my successors, heirs, assigns, executors, administrators, spouse and next of kin:

- I. Agree that prior to participating I will inspect the facilities, equipment and areas to be used, and, if I believe any of them are unsafe, I will immediately advise the person supervising the event, activity, facility or area;
- II. Acknowledge that I fully understand that my participation may involve risk of serious injury or death, including economic losses, which may result not only from my own actions, inactions or negligence, but also from the actions, inactions or negligence of others, the condition of the facilities, equipment or areas where the event or activity is being conducted, the rules of play of this type of event or activity;
- III. Assume any and all risks of bodily injuries to myself, including medical or hospital bills, permanent or partial disability, death and damages to my property, caused by or arising from my participation in this event or activity;
- IV. Covenant not to sue, or present any claim for personal injury, property damage or wrongful death against the City of Long Beach and their officers, employees and agents for damages attributable to my participation in the event or activity;
- V. Release, waive, discharge and relinquish the City of Long Beach and their officers, employees and agents from any liability, loss, damage, claim, demand or cause of action against them arising from or attributable to my participation in the event or activity, whether same shall arise by their negligence or otherwise;
- VI. Agree that photographs, pictures, slides, movies or videos of me may be taken in connection with my participation in this event or activity without compensation from the City of Long Beach and consent to the use of these photographs, pictures, slides, movies or videos for any legal purpose;
