We use Housing-First/Harm-Reduction Principles to include, but not to exclude, participants in our program. Housing types & services are voluntary, client directed & focused on securing permanent housing (PH) as quickly & safely as possible. We offer supportive services, case management, benefits linkages (SSI/SSDI), licensed mental health services, life skills, income enhancement, legal services & substance use education to create future housing stability. At entry, clients receive individual service plans for services either within our organization or via referrals to service partners who address needs after PH transition.

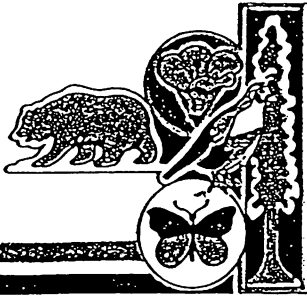


