The Long Beach Continuum of Care planning grant would allow for the Long Beach CoC to expand on all responsibilities laid out in 24 CFR 578.7 in operating the CoC and having planning efforts. The funding would be utilized in engaging with newly funded projects as part of the HUD Special NOFO program in setting up their HMIS programs, ensuring that new programs are aware of and utilizing all Long Beach CoC written standards and participating in the Long Beach Coordinated Entry System. This funding would ensure ongoing capacity to provide high quality engagement with all newly funding programs as well as the Continuum of Care boards and committees. One new area that the funding would be utilized in match with other funding sources is staffing and financial support for creating a permanent Lived Experience Advisory Board as part of the Long Beach Continuum of Care to ensure that we are consistently working to raise up the voice of people with lived experience and ensuring that it is being incorporated into our administrative and planning efforts as a CoC.

The CoC will also utilize funding to increase its planning efforts. One area of particular focus in the planning area is increasing coordination, integration and alignment will be with our managed care providers who are managing the healthcare needs of people receiving Medicaid insurance. Funding will also be utilized to continue to find ways of integrating and utilizing funding that is coming from the State of California, County of Los Angeles and City of Long Beach to address the needs of people experiencing homelessness and ensuring that all resources are being aligned and leveraged in the efforts of ending homelessness.

2. Describe the estimated schedule for the proposed activities, the management plan, and the method for assuring effective and timely completion of all work.

The Long Beach Department of Health and Human Services (DHHS) is confident that all efforts within the proposed activities could begin upon completion of a contractual agreement. Many of the activities that are in various stages of planning and implementation currently and new funding would be utilized to enhance efforts and ensure that they are sustainable into the future. Long Beach would ensure that all activities and plans laid out within this project are being tracked at various levels of leadership within DHHS to ensure that there is internal accountability and tracking. Additionally, DHHS would be providing reports and updates regarding CoC activities, plans and status to the CoC Board and various subcommittees on a semi-annual basis so that they are aware and monitoring implementation and that the work identified is being completed, as well as the creation of the Lived Experience Advisory Board will be a major piece in tracking and ensuring that what is identified around enhancing the Long Beach CoC governance is being completed.

The proposed funds will allow DHHS staff to further provide technical assistance to agencies on the front end to ensure that projects are incorporating all requirements into their practices and well as utilizing evidence-based practices within their work. Funding will ensure that DHHS can maintain both offsite and onsite monitoring for newly funded CoC projects on an annual basis to ensure compliance, monitoring the progress towards project goals and evaluating outcomes within each project. This grant will be a piece of ongoing efforts of the CoC to improve its outcome tracking and setting annual targets for all homeless service programs including those that are funded through the CoC and ESG programs.
