The Long Beach Department of Health and Human Services, Homeless Services Bureau (HSB) has served as the lead agency and sole recipient of funding for the Long Beach Continuum of Care (CoC) since the inception of the CoC grant competition. As the CoC lead agency and UFA entity, HSB is responsible for implementation, operation, management, and administration of the Long Beach Continuum of Care and Long Beach Coordinated Entry System. As the designated lead and administrative entity for the CoC, the HSB prepares the annual project ranking, and prepares and submits the annual consolidated CoC application to HUD. Upon award, the HSB coordinates with its partnering providers on the implementation of program funding, developing, and executing subrecipient agreements. Upon execution of its subrecipient agreements, the HSB actively administers and manages subrecipient programs and contracts, monitoring subrecipients for financial and programmatic performance, ensuring compliance with the CoC Program application and all applicable federal guidance, policies, statutes, and regulations. The HSB, as the grantee and grantor of HUD CoC funds for the Long Beach Continuum of Care, works to ensure grant funds are optimized and maximized, and that there is sufficient cash flow to carry out CoC program operations. This is achieved via timely review and approval of subrecipient invoices, as well as timely submission of claims for reimbursement, drawing all project funds directly from HUD through LOCCS and distributing funds to subrecipients. To ensure compliance with match and leverage requirements, the HSB documents its aggregate match obligation of 25%. The HSB regularly reviews and monitors program data for data integrity and data quality, formally documenting and reporting CoC data via preparation and submission of an Annual Performance Report.
