Proposed Project: A request for a major Certificate of Appropriateness to allow a rooftop addition of 3,345 square foot, rooftop addition of 3,345 square foot, consisting of an trellis covered community garden and accessory circulation areas, and exterior modifications to the building. The project includes the adaptive reuse of an existing 6-story commercial building into 69 residential units on the upper floors. Of these units, 11% are designated as very low income and 9% are moderate income. The property is located at 115 Pine Avenue in the PD-30 Zoning district and is a designated Historic Landmark known as First National Bank of Long Beach Building (District 1).

This project **IS NOT** in the Coastal Zone and **IS NOT** appealable to the Coastal Commission.

There may be other time limits which also affect your ability to seek judicial review.
