The property is located at 3724 Lewis Avenue, within the California Heights Historic District and the existing primary residence is a Non-Contributing Structure in the R-1-N Zoning District. If you seek judicial review of any decision of the City pursuant to California Code of Civil Procedure Section 1094.5, the petition for writ of mandate pursuant to that section must be filed no later than the 90<sup>th</sup> day following the date on which the City's decision became final pursuant to California Code of Civil Procedure Section 1094.6. There may be other time limits which also affect your ability to seek judicial review.
