- Approval(s) Requested:** Modification to an Approved Permit
- Proposed Project:** Modification to a previously approved Long Beach Municipal Stormwater Treatment (LB-MUST) Project (App. No 1807-12) to relocate the proposed wetlands to a 1.23-acre site across the street from the LB-MUST Treatment Facility at 901 De Forest Avenue. The scope of work includes installation of a 4-inch forcemain from existing pump station SD-02 to the LB-MUST Treatment Facility and to the new wetland location, which is not subject to Site Plan Review (SPR) but is included in the environmental analysis prepared for this project scope.

This project **IS NOT** in the Coastal Zone and **IS NOT** appealable to the Coastal Commission.

- Environmental Review:** This project was analyzed as part of the previously-adopted Mitigated Negative Declaration (ND 03-17) for the Long Beach Municipal Urban Stormwater Treatment (MUST) Project (State Clearinghouse No. 2017071068), and will not result in any new significant impacts. If you seek judicial review of any decision of the City pursuant to California Code of Civil Procedure Section 1094.5, the petition for writ of mandate pursuant to that section must be filed no later than the 90th day following the date on which the City's decision became final pursuant to California Code of Civil Procedure Section 1094.6. There may be other time limits which also affect your ability to seek judicial review.
